Coverage: generally 1946 to the present, with some older material.



#### **Embase**

Embase is a biomedical and pharmacological database containing bibliographic records with citations, abstracts and indexing derived from biomedical articles in peer reviewed journals, and is especially strong in its coverage of drug and pharmaceutical research. Coverage 1974-present. Embase is produced by Elsevier

The Cochrane Collaboration is an international network of more than 28,000 dedicated people from over 100 countries. We work together to help healthcare providers, policy-makers, patients, their advocates and carers, make well-informed decisions about health care, by preparing, updating, and promoting the accessibility of Cochrane Reviews. Cochrane Library consists of several subdatabases, i.e. Cochrane Database of Systematic Reviews and Cochrane Central with randomized studies from Medline, Embase and Special Registers. Cochrane Library also enholds the largest collections of links to trials, including clinicaltrials.gov, trials conducted in the EU, and trials within WHO member states, searchable in Cochrane Central.

# **Epistemonikos**

Epistemonikos is a collaborative, multilingual database of health evidence. It is the largest source of systematic reviews relevant for health-decision making, and a large source of other types of scientific evidence. Epistemonikos was founded by Gabriel Rada and Daniel Pérez. It is now maintained by Epistemonikos foundation, a not for profit organization based in Santiago, Chile.

The Web site is maintained by the National Library of Medicine (NLM) at the National Institutes of Health (NIH). Information on ClinicalTrials.gov is provided and updated by the sponsor or principal investigator of the clinical study. Studies are generally submitted to the Web site (that is, registered) when they begin, and the information on the site is updated throughout the study. In some cases, results of the study are submitted after the study ends. This Web site and database of clinical studies is commonly referred to as a "registry and results database

PROSPERO is an international database of prospectively registered systematic reviews in health and social care, welfare, public health, education, crime, justice, and international development, where there is a health related outcome. Key features from the review protocol are recorded and maintained as a permanent record. PROSPERO aims to provide a comprehensive listing of systematic reviews registered at inception to help avoid duplication and reduce opportunity for reporting bias by enabling comparison of the completed review with what was planned in the protocol. PROSPERO is produced by CRD and funded by the National Institute for Health Research (NIHR)

## **HTA database (INAHTA)**

The international HTA database provides free access to bibliographic information about ongoing and published health technology assessments commissioned or undertaken by HTA organisations from around the world. This includes INAHTA members and non-INAHTA members. The database provides a single point of access to information that would otherwise be more difficult and time-consuming to search for on individual agency websites.

INAHTA has taken on the responsibility for the production of the HTA database. This was previously done by the Centre for Reviews and Dissemination (CRD), University of York, England. The database was started by the CRD in 1996 and, in fact, it used the INAHTA Briefs as a seed database for the new international platform.

## **Health Systems Evidence, HSE**

Health Systems Evidence is a continuously updated repository of syntheses of research evidence about governance, financial and delivery arrangements within health systems, and about implementation strategies that can support change in health systems. The types of syntheses include evidence briefs for policy, overviews of systematic reviews, systematic reviews, systematic reviews in progress (i.e., protocols for systematic reviews), and systematic reviews being planned (i.e., registered titles for systematic reviews). Health Systems Evidence also contains a continuously updated repository of economic



evaluations in these same domains, descriptions of health system reforms (with links to syntheses and economic evaluations when possible), and descriptions of health systems (to assist with assessments of the local applicability of research evidence and of how reforms are embedded within health systems). other advanced features
